




Polarity mark






RELATIVE INTENSITY vs. WAVELENGTH




SPATIAL DISTRIBUTION




SUPER BRIGHT ORANGE




REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

REEL DIMENSION (units : mm)




